This resource was presented at ParlAmericas' **Parliamentary exchange: Multi-party caucuses for gender equality** held in Ottawa, Canada, in October 2016, and organized in collaboration with UN Women's Multi-Country Office for the Caribbean and the All-Party Women's Caucus of the Canadian Parliament.

This questionnaire was adapted from the original developed by Dr. Sonia Palmieri and published in [A Comparative Study of Structures for Women MPs in the OSCE Region](#).¹
